President/CEO's Report

Ms. Carrier reported that the lodging tax was down 46% for April and 35.2% for the year. May is looking better than previous months and the first weekend of June was a great weekend. Ms. Carrier said she in the process of revising the 2020 budget and should be ready for presentation to the board by next meeting. The Ruston Sports Complex is continuing to host tournaments of various sizes each weekend. She announced that she had a meeting with the mayor two weeks ago and the conversation is ongoing as to how the CVB and complex can partner. Interviews for the marketing director position have concluded; Ms. Carrier stated she hoped to be making an offer in the coming weeks. Ms. Carrier also announced that it has been requested from the president of the Louisiana CVB's Association that each organization release a statement addresses racial discrimination. Ms. Carrier will email out a draft of the CVB's statement.

Sales and Marketing Report

Ms. Carrier reported that the CVB has taken advantage of the \$3K marketing granted offered by LOT. The CVB is beginning to turn back on SEM campaigns and social media campaigns.
