#### Call to Order

Mr. Perot called the meeting to order at 8:08 a.m.

# President/CEO's Report

Ms. Carrier reported that lodging tax was up 119.45% for April and up 60.59% year-todate. Ms. Carrier shared that the Louisiana Peach Festival was a great success with more than 15,000 people in attendance.

Ms. Carrier requested approval on a board resolution to enter into grant agreements with the Louisiana Office of Tourism (LOT) on behalf of the CVB for FY 21-22.

#### Sales and Marketing Report

Ms. Davis presented the sales and marketing report. She shared that there were 10 events in Ruston & Lincoln Parish throughout May. The CVB was also recently awarded a \$20,000 marketing grant from LOT.

Mr. Owens presented the Treasurer's report. He reported that revenues exceeded expenses for the month of May. Expenses exceeded revenues for the year.
